The Business of Revolution

How close are we to revolution? Part of the answer lies in the fact that fewer than one in a thousand even understands the real meaning of the word. Revolution doesn't involve politics, ideology, or anything abstract. It is a very physical term. The dictionary defines revolution as a sudden, radical, and complete change and we wouldn't attempt here to best that definition. Men make revolutions. Men who are passionately motivated, to be sure. But the bars are loaded with passionate men who do nothing more than gripe bitterly and continue to drink away their minds and livers.

Revolutionaries make revolutions. The conditions today are ripe for picking and getting better all the time. But why no revolution? We look at the classic examples of history and hope to find an answer. We see miserable, unjust conditions abounding as a way of life and we certainly have no shortage of these same conditions here. We examine all the lessons of history searching for parallels. At length, we recognize from pictures of the eras of great revolutions that there are masses of hardened, matured men in the streets and at once we know we have hit upon the answer.

Men who are angry to the point of action. Men who cannot be sidetracked or bought off. Not necessarily idealists or deep social thinkers but men who are real and basic enough to still respond to the calling of their gut instincts. Men who know life. Men who have served in war and who have lived by their hands and muscles. But men who are no fools, who ignore trifles, and who are solidly intent upon one thing: Seizure of power.

These men exist today in this country and they exist in the millions. However, these men represent blind inertia, dead weight, and naked force and reaction. They are unconscious of themselves and of their role. History does repeat itself but only in the broadest generalities. The intricacies of the progression of events are never the same twice. And so we are left without a real pattern. We are left struggling with ourselves to muster the strength and wisdom to seize the revolution which is coming inexorably lest we become its victims.

The difference we have to overcome here today that was not encountered by those great revolutionaries of the past is that the masses are not out there waiting for us, to greet us. Thus, the game board has shrunk while the stakes remain the highest. We have said that it is up to the revolutionaries themselves. If the masses were in the streets today, we would already have lost for we are not ready to take them in charge. The opposition is much closer to that point than we are and, with that in mind, it can be comforting at times to witness the lethargy of the people.

Again to the nature of revolution, when does a revolution begin and when has it become complete? The example of a fixed point on a sphere rotating on an axial only partially can apply in social terms. The point is at its complete opposite when one-half a turn is made and, after total revolution, it has arrived back at its beginning. Still, in terms of both physics and human events, motion and degrees are involved. All throughout history announced revolutions have been stillborn while actual ones have been deposed and devoured by others. In times of revolution, power is the object and it is up for grabs. Never was this more true than in the United States today.

Let us satisfy ourselves that, at present, our "troops" are in the vast majority and should remain so until some point following the turn of the century. By that time we'd damned well better have long since prepared ourselves for the move. We are today showing every sign that we can and will be ready. We indeed. Most of those who will exercise guiding hands in the revolution don't know who they are as yet. Many are not born as yet. And what sort will they be?

There is one thing that exists in history without change. That is that revolutionaries are born. Conditions into which they are born do not make them but merely awaken them, steel them. Because today the business of revolution can easily be a part-time affair, that is why the shape of so many would-be revolutionists is so laughable. When the moment strikes, the silly, stupid grin will disappear from the national face and the hour of the revolutionary will be upon us.

Only those daring and capable enough to ride the eye of the storm will survive. When all smile and pretense are finally dropped, then the day of the conservative and the reactionary will be at an end and the predators will battle for dominance. In that battle and following it, all the weak and half-hearted, all the fence-straddlers and hobbyists will perish as victims. As the storm moves to its climax and from that point onward, the representatives of the old order will be slaughtered. At the end will come the fall of one or the other tidal force. The victor will have been the fittest.

The outcome will be permanent. Only the force of Nature will be able to end the reign of the victor for no opposition will be left alive. If you reading this are under the age of forty, you most probably will live to witness at least a part of this. Sadly, most who will witness it have no power of choice as to the role they will play. Most are not only not equal to the time, they are not even equal to the opposition. What prayer have they? Take your cue from the opposition. Admire him. Emulate him. Strive to out-do him. There is your only hope.

Hardness, stoicism, will, vengeance. Power is the object and survival is the key. Only those who kill their enemies will survive. How they fantasize of what they'd "like to do" with the opposition today, with their overlords, with their tormentors. Given the chance today, how many of you could, in cold blood, dispatch with a pistol shot to the head at point-blank range a snivelling, anti-White judge, politician, or integrationist who is today lording it over you in luxury? Having him tied to a chair before you and in your hand the power and instrument of eternal justice, how many would have the stomach, be equal to the moment?

We sneer at all the many miserable, disgruntled reactionaries who dream endlessly of what they'd do with this liberal, or that renegade White, or this sell-out official, or that colored. How many, if it were in their power at the moment, would have it in them to give the command for the liquidation of millions of captured counter-revolutionaries? For the execution of arrested government officials? For the deaths of anonymous men, women, and children who happen to be on the wrong side of the color line?

Precious few. And in direct relation to that tiny number of total revolutionaries lies the distance we are away from and, more importantly, the title of the victor of the coming revolution. Totality. Consider it and face the reality of what your place will be in the future.

The men, the leaders, the masters of the storm are among us today. Their lieutenants are still among the children and the unborn. In this soft, easy time of choice they have chosen the hard road of building revolution. They are in the streets. They are in the jails. They are the passionate ones. They are the ones following the commands of their hearts. They are the ones being persecuted and suppressed by the existing order. And they are the ones receiving the most important training of all.

Unless they can willingly stand forth and make the dare, unless they can endure and survive what punishment the system can dish out, unless they can do this and lash back, then they are neither worthy or capable to claim the right to deal death to the system and raise up one of their own.

That then is the business of revolution. It is serious business, deadly business. No kind of game. There is no choice in involvement. There is only the choice of shirking and dying or of fighting and possibly surviving. Those who haven't thought of it don't matter. Those who have thought of it should think deeper.

In this issue of the Ohio National Socialist we mention the names of two more from among the very best of George Lincoln Rockwell's old guard of the American Nazi Party: Capt. Robert A. Lloyd, III and Lt. William G. Kirstein.

Robert Lloyd had come to Rockwell at the age of seventeen and had served him faithfully and with outstanding merit over the following decade. After Rockwell's assassination, Lloyd was instrumental in keeping the movement alive and advancing together in his capacity as Party Executive Officer. Your Editor is proud to have served directly under Lloyd during the latter's tenure as Party Exec.

William Kirstein was another young recruit of Rockwell's. Eventhough Kirstein called the West Coast home, specifically the Fresno, Cal., area, he was trained by Cmdr. Rockwell at A.N.P. Hq. at Arlington. Kirstein served with distinction as a stormtroop lieutenant and was involved in many bloody attacks upon Reds and Blacks. Kirstein served also for a time as Party National Organizer.

Both these men are heroes in the realst sense. Both played key roles in the sustaining and building of the movement. These were Rockwell's men, no other's. Rockwell inspired them, trained them, invested them with their rank. In two more criminal displays of folly, the powers controlling the NSWPP sought to expel and disgrace these two magnificent officers.

These men have our thanks and our salute. But we are not content to leave it at that. We want to hear from these men or be put in contact with them. We want them back. They must know that injustice will not reign forever over the affairs of Rockwell's Party. We need them. They deserve the recognition and the authority.

ONLY FAILURE IS IMMORAL...

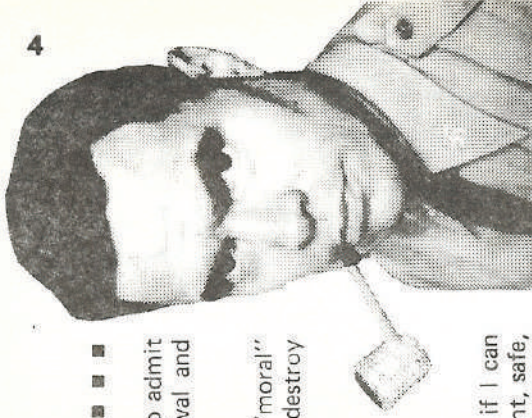

State court refuses assault case

COLUMBUS, Ohio (AP) — The Supreme Court today refused to review the assault conviction of a member of the American Nazi Party who was accused of spraying the disabling chemical Mace on three black school children.

The decision came in the case of Gregory L. Hurles of Chillicothe, who was convicted of spraying the junior high school students in a drive-in parking lot on Oct. 1, 1973.

Hurles claimed pretrial publicity on the case made a fair trial impossible. He cited 22 articles in the Chillicothe Gazette, many identifying him as a member of the National Socialist White People's Party, more commonly known as the American Nazi Party.

The 4th District Court of Appeals rejected that contention.

"The articles here considered are for the most part factual in nature," the 4th District said. "Clearly they are not of the inflammatory, biased or invidious nature tending to arouse ill will and vindictiveness."

The court also noted that only one prospective juror was aware of Hurles' Nazi connection, and all jurors said they had an open mind on the case.

It was that ruling which Hurles attempted to appeal.

"They're scared to death."

These were the words used by one high-ranking Chillicothe official in describing the condition of the "City Fathers" during the height of the present, three-year-old court battle involving assault convictions against two Chillicothe comrades.

Make no mistake however. Scared, yes. But not of us. Scared of the niggers. Scared that unless they bent over backward to railroad two National Socialists the big, bad boogies might damage their lilly-white skins. Or, maybe even worse, the local NAACP might cause damage to their precious political careers.

One thing's for sure, the filthy swine in control of Chillicothe city hall are not stupid. Physical and moral cowards, perhaps. But not stupid. They know which way the wind blows and which side the bread is buttered on. If they value their sweet asses, as they do, then they know exactly who to appease, who to suck up to, and who to kick.

And so we present this case study in the workings of modern, present-day liberal-democratic government. Mob rule goes a long way. Just the implied threat of mob violence goes even further. We are governed by weaklings. Weaklings plus power equal tyranny. As long as fear is the key, then as long as they fear the Blacks more than they fear us we can forget about "justice".

The movement learned the truth, eventhough it had been suspected all along, in September of 1974 during se-cret talks with a court official in his Chillicothe office when the case was already a year old. The O.N.S. Editor poked his head around the office door and, without need of introduction, was invited to have a seat.

During the most lucid and cordial conversation, the court officer made frequent use of the terms "niggers" and "coons" while gesturing toward the colored district only a half-block from his office. It was definitely not a case of love lost but plain, old-fashioned terror and expediency.

This man, not being on the firing-line himself, was more than willing to discuss a truce and he made it abundantly clear that the city wished that the whole thing could be "dead and buried." Your Editor concurred but quickly added that the National Socialists would not be the ones to take a dive.

Sentencing

Gregory Hurles, whose assault conviction the Ohio Supreme Court refused to review, will appear in Municipal Court for sentencing.

Hurles, 30, ~~was sentenced~~, served only one week of his six-month sentence in the Cincinnati Workhouse before his release, pending the appeal. Court records indicate he also has a \$200 fine and \$321 in court costs he has not paid.

Hurles, a member of the National Socialist White People's Party, more commonly known as the American Nazi Party, was convicted by a jury in connection with the assault of black youths in the Dairy Queen parking lot, North High Street.

James N. Mason, also a Nazi Party member, was convicted of assault in the same incident.

Hurles was charged with aiding and abetting.

Sentencing for Hurles will not be held until official notice of the denial of appeal is officially sent to the Municipal Court.

Hurles appealed his conviction on the basis that pretrial publicity by the Gazette made it impossible for him to receive a fair trial.

It began in October of 1973 with the arrests on charges of assaulting a number of Negro youths in Chillicothe. The arrests came immediately on the heels of a series of threats of arrest, calls to come "downtown" for questioning, petty harassment, and, more significantly, an upsurge in political activity that had been sustained all throughout that year. National Socialists had been on radio the very morning of the arrests.

Det. Capt. James "Nigger" Harris was told in a rather ho-hum fashion that we were getting a little bored with his tactics and to either arrest us or let us go. But, he was warned, should we ever be arrested for any reason, the thing would blow up like an atomic bomb. He didn't choose to believe it. We were read our rights and booked.

Records were then set. Records for high-handed police and court pressure. And records for Nazi activity and publicity for the Chillicothe area. Obstacles were thrown before the prosecution as the National Socialists demanded court-appointed attorneys and also, just to be sure, enlisted the support of the Ohio A.C.L.U. The bastards started it, let them pay for it!

"Sweet" William Sammons, presiding judge, acted as though he didn't know quite how to act at the arraignment when he looked to "Nigger" Harris to name the bond. Fifteen hundred dollars apiece for the misdemeanor! Next, he came on with a favorite B.S. line of his stating that no attorneys could be appointed. Bond was quickly made and, after the A.C.L.U. jumped into Sammons' shit, lawyers were appointed without delay.

The "trials" were conducted on the basis of the prosecution's four "positive" nigger witnesses. Actually, only one was required but they wanted to be thorough. Despite the defense's superior number of offsetting witnesses, politics convicted the National Socialists. (Politics, that is, plus fear.)

The sentences were the maximum, of course: Six months, two hundred dollars, plus court costs. Destination: Cincinnati Workhouse, reputedly the worst rat-hole in the State. The orders were to "convoy immediately". But the decision was quickly appealed, a new bond made, and the fun was joined in full.

Niggers and sick Whites began the chorus of why weren't these impudent Nazis being stopped? Knowing that the scam was referred to as the "City Hall Clique" were all bedfellows (in more than one sense), the Nazis decided to strike an offensive and blow a hole in their apparently solid wall of smug bureaucracy. The County Fair Board was the target. Asses were being kicked while the defensive side was gaining steam. A shower of publicity and interviews followed.

The judge had his fat, plutocratic ass dragged onto the carpet of the Bar Association and it was demanded of him WHY he and his machine were unable to stop the Nazis. Letters to the editor of the town newspaper were appearing asking the same thing. The sons of bitches were TRYING with everything they had but it fell short of being enough.

The power of City Hall to crush all opposition was losing credibility fast. Others might be picking up the idea. The "word" was carefully gotten to the Court of Appeals to give these cases special handling. Rallies were held, appeals were knocked down, new appeals were filed in higher court, the County Fair was blown apart, and publicity continued.

It was all beyond the comprehension of the average person. The Nazis wouldn't scare, much less panic. They weren't impressed and they wouldn't bow. HOW those democratic swine must have wrenched their minds trying to figure why their control apparatus' full weight was failing so completely. It was as though they were trying to put out a fire by dousing it with gasoline.

Democratic, hide-behind-the-law, measures of suppression worked extremely well in holding the rest of the population submissive and docile. They fell flat in dealing with determined revolutionaries. Usually, these bastards could depend on nothing more than the imagination of the common man to keep him in check. Things seldom ever got past the point of the victim's being dragged out of the tank and into the imposing atmosphere of the courtroom itself.

Police frames, exorbitant bonds, slander in the press, nightmarish legal proceedings, threats of violence against families and homes, maximum prison sentences and fines, all amounted to naught. Did they ever reflect, if World War Two didn't stop them, what chance was there now? "There's no stopping them!", they must have cursed to themselves more than once.

Died-in-the-wool conservatives that they are, they weren't acting out of love for the Blacks. Justice wasn't their goal. Primarily, they wanted desperately to get the heat off themselves. The "heat" being represented by the peculiar car tagged New York State present at the court house for the opening trial. Secondly, they were enraged at the sight of men standing up and spitting in their faces.

Having one of the iron laws of this revolution clearly demonstrated, it became increasingly clear that one cannot work within the System even for one's simple defense. All appeals were exhausted. Your Editor was first to enter upon and complete his sentence. History was repeating itself and we discovered that our friends at that ancient dungeon were legion. The stay was a memorable one. Advanced education at State expense.

Sentence

Gregory Hurles, 268Birmingham, was sent to the Ross County Jail today to finish his six-month sentence on a conviction of aiding and abetting an assault on black youths.

Hurles, whose conviction was refused for review by the Ohio Supreme Court, appeared today in Municipal Court.

Hurles had appealed his conviction on the basis that pretrial publicity by the Gazette made it impossible for him to receive a fair trial.

Hurles' fine and court costs total \$521.

The epilogue to this story has to be that, even in the moment of what was their assumed victory over the National Socialists, when the first of the sentences was reimposed, an error was made. Due to the long, tenuous process of the appeals, the prosecutions fell out of synchronization. Both comrades were not confined simultaneously. Organization continued. The effect was that of an insidious gas seeping under a door vainly slammed shut.

A technical error which nullified the entire point of the thing. A small tactical mistake hardly noticed but the kind of mistake that has lost wars.

The main thrust of our defensive action in the immediate sense was a rather narrow, personal one. Before pronouncing sentence upon your Editor in the first month of this three-year-old battle, the judge thought he'd be very theatrical and make a little speech. To the effect, "We don't want to, don't have to, and aren't going to put up with you..." The goal was to see to it that that disgusting pig was made to eat those words.

Within seconds of his uttering those pompous phrases, one lone Nazi was being sped, handcuffed to a Civil War F.O.W. prison a hundred miles away. Within two weeks, the National Socialist had returned. That foolish person did eat his words long before the full implications of the struggle became realized. Success in the short range.

A second mistake was made by each individual who was either involved or implicated in that arrest or prosecution. A very personal, haunting kind of mistake. A mistake that, when considered from the point of its maker, causes me to shudder for them. We had DARED to spit on their power and authority. They descended upon us with full fury. We emerged a wee bit more invigorated than before. They obviously couldn't, or did not choose to see what they had created for themselves. They made an unwitting and infinitely more fateful dare also.

The gravest mistake they made was in not having us killed while we were in prison. Either they didn't have the guts or they didn't take us seriously. For them, the outcome will be the same.

The greatest travesty would be for them to die natural deaths. If the full measure of good fortune is with them, senility will claim them first. In the end, it was a matter of them or us. The comedy of this story is that they don't believe it still is.

City case appealed in federal court

Gregory Hurles, 268B Birmingham Ave., who was convicted as an accomplice in an assault on black teenagers has filed a petition testing the legality of his imprisonment.

Attorneys representing Hurles filed a petition with the U.S. District Court in Columbus for a writ of habeas corpus this week. Louis A. Jacobs and Stanley K. Leeghins Jr., of the College of Law/Clinical Programs at Ohio State University, are handling the Hurles case.

The attorneys contend

Hurles is being held in jail in violation of his constitutional rights because motions for a change of venue and to strike evidence obtained in a pre-trial identification were overruled by Municipal Court Judge William E. Sammons.

The change of venue motion was filed because defense attorneys claimed Gazette articles identifying Hurles as a member of the National Socialist White People's Party, commonly known as the American Nazi Party, were prejudicial.

The Ohio Fourth District Court of Appeals upheld the Municipal Court conviction and the Ohio Supreme Court recently refused to hear the case.

Hurles was sent to the Ross County Jail Feb. 10 to finish his six-month jail term. He had been released pending his appeals to the Ohio courts.

The circumstances which have allowed Hurles appeal his case to the federal court without following appeals through the post-conviction proceedings are ironic.

Hurles was originally charged under state statute but the charge was refiled under a city ordinance so the court could appoint an attorney to defend him.

The court could not legally appoint a defense counsel if Hurles had been charged under the state law.

Federal court rules prohibit the handling of a case until all avenues of appeal at the local and state level have been met — unless the charge is filed under a municipal ordinance. Hurles had not exhausted all possible appeals.

First Quarter of Bi-Centennial Gears For Organization

Not only is the N.S.M. striving to reactivate the best people nationally but we aren't forgetting our own back yard either. Meetings have been including former activists of nearly ten years ago.

Movement Makes Overtures To Religious Communities

Throughout the existence of organized National Socialist drive for race and nation, no opportunity has ever been overlooked for a chance to gain inroads into the minds of those fanatical persons who merely happened to have been siphoned away from the real fight and into various "religious" causes. A Message From the N.S.M. Chairman

In a personal reply to one comrade who happens to hold a post within the N.S.W.P.F., Chairman Robert Brannen outlines the movement's arguments against and position toward that organization. The letter is similar to dozens of others we have received in the past year. We trust it will prove enlightening and helpful to our general readership as well.

March 8th, 1976 MF-87

National Socialist Comrade:

Received your letter the other day and will give you the facts as I know them about the NSWFP in Arlington. I am extremely busy - working at the plant five days a week and with a gang of young ones at home. With our mailings of the Ohio N.S., our weekly contacts, and our outside activities, the continuing increase in mail volume makes me, as you can imagine, one hell of a busy man.

By this time, you should have received a letter from the C.N.S. Editor who does handle a lot of our work load and correspondence but I eventually get around to answering every letter personally although this may cease, out of necessity, in the not too distant future.

Personally, I dislike form letters as they usually are too cold and say nothing except "thanks for your support". Although, when we do finally go to form letters, I will dictate their contents.

First I guess you should know some of my background and the intentions of our N.S. Movement. You might say that I am up in the years... forty-nine... but I have been around. As a boy, I was in the Second World War and when I came home shortly thereafter certain events happened on the national scene that alerted me to treason by our government officials and, of course, I was dismayed at their cooperation with the Communist states.

I was young then... nineteen... but I started searching for the truth. I came to the same conclusions that Rockwell did and in about the same manner. If you've read Rockwell's "White Power", you'll know what I mean.

By 1957 I had joined various organizations and had really gotten into the nitty-gritty, double-dealing espionage of some of these organizations. I might sometime go into the details but it covers a good ten years of travel across the United States, sitting in on this and that meeting, making contacts and pulling this and that caper. And, of course, in and out of jail occasionally on minor charges. (Never did they nab me on anything worthwhile.) At the same time, trying to raise five boys and five girls.

I had the honor of meeting Lincoln Rockwell a number of times. He was a real leader, dynamic, great. No doubt of it. I have known and met quite a few leaders of other organizations also but, finally in 1968, I submitted an application to join the NSWFP. The information given on my membership application should have provided Matt Koehl with a good insight into my background and usefulness to the movement.

But, surprisingly, he never "used me" to his advantage or to the advantage of the Party. The know-how and skills I had would have been a real asset to his organization.

Of course though, we know, and I assume that you know, that in any area it takes someone who is willing to take the initiative for the cause. This takes someone dedicated and willing to lay down his life for what he believes in. Incidentally, you will not find this in most so-called "right wing" organizations.

Now we come to the 1970's. I had worked hard in Cincinnati and the surrounding area for the NSWPP. I did not ask for any recognition - only to spread the word for the movement and to build it. There were a number of us here but, honestly, it was at my direction, procuring meeting halls, getting the men on the streets, etc.

In 1970 at Arlington, there was a dispute between Koehl, Dr. William Pierce, and Mr. Robert Lloyd. This ended in Pierce's and Lloyd's leaving the Party. Pierce was the initiative and the brains behind all propaganda, White Power Messages, etc., while Lloyd was the Party ramrod seeing to it that things got done. Both were damned good men.

From this point the NSWPP started to falter. The contributions made by Pierce and Lloyd plus the strength of the outlying units kept the Party going for a few more years. But, in 1973, even this was finally destroyed and erased. With the loss of Unit Leaders such as Casey Kalemba and Joe Tommasi, Party organization began failing badly. Old-timers started questioning Koehl's leadership and intentions.

In 1974 I was dismissed from the NSWPP. I demanded an explanation but none was given. Regardless, I kept tendering my membership dues and instigating activities for the NSWPP for one year following that. Finally, I told Cedric Syrdahl, via telephone, that I was still a National Socialist but when Arlington could not do me the courtesy of answering letters, acknowledging receipt of money, or even informing me of the charges they had against me, I was done with them.

Under the circumstances, I think I gave them enough time in demonstrating my loyalty to the cause but now I question the leadership. I was told that it was "treason" to question the leadership.

My answer was that, as a National Socialist, I believe in being fair, honest, and man enough to tell a person what he has been charged with and why he has been dismissed from the Party. And if they cannot be decent about it, then I think I am with the wrong people. I believe in fair play and honesty with my comrades, those who are willing to go into the streets and chance getting their heads bashed in.

In the end, I went my way and kept the N.S. Movement alive here in Southern Ohio. I got in touch with Captain Tommasi, who I also knew personally, and with other NS men, have been steadily working for the cause.

To top it all, the most asinine thing that Koehl ever did was to spread such hatred throughout the remaining ranks against Joe Tommasi that eventually one of the youths shot him. That Koehl must have feared Tommasi's leadership is the only explanation. Tommasi's death was the death knell of the NSWPP regardless.

I want to commend you on your National Socialist stand and I want to reemphasize that together we will win, have no doubts about it. It is men like yourself that are keeping the movement alive. With the cooperation of all of us working together we will come to power.
