1. THE INTERNATIONAL NAZI: Many people that will receive this bulletin have been waiting for the magazine, "The International Nazi" to be issued. Due to the lack of printing facilities, the first issue which was originally scheduled for March, will be delayed until such time as WUFENS will be able to secure proper printing equipment.
2. FLORIDA STATE COMMANDER: John W. Hamilton, was appointed Florida State Commander of WUFENS in March 1960. Mr. Hamilton was given this post in view of his past experience and outstanding record in this fight. Many people reading this bulletin probably have read "The White Sentinel" which was founded by Mr. Hamilton. Mr. Hamilton has been a devoted National Socialist for the past twenty years, and has suffered much persecution. 3. NEW FOUNDATIONS: As Assistant Editor and part financier of the National Socialist publication "New Foundations", it came to me as somewhat of a shock to learn that the subscription fee had been returned to the subscribers and that "New Foundations" had ceased publication. Mr. Ronald S. Patterson, who was known to many only through mail contact (including myself) seems to have had little contact with other National Socialist. Patterson even goes so far as NOT to answer letters these days. It is my guess that the ADL has given him the intimidation treatment.
4. NATIONAL STATES RIGHTS CONVENTION: The National States Rights Party held its National Convention in Dayton, Ohio on March 19, 1960. Commander Rockwell attended the meeting as the guest of one of our members. 5. SOUTH AFRICA: According to the reports in several Jewish Newspapers, MOST of the Jewish LEADERS in South Africa have been arrested for conspiring against the Governments RACIAL laws, and inciting the Negroes to REVOLT. Only imprisonment of these vile Kikes will tend to keep the South African Negro from rioting against the White Government. South Africa has a large Jewish colony.
6. WOLF RUEDIGER HESS: Son of the famous war hero Rudolf Hess, who is now imprisoned by the Jews, is being drafted into the West German Army---even though he protests, because of the illegal imprisonment of his father---who's only crime was and is opposing INTERNATIONAL JEWISH COMMUNISM.
7. COMMANDER ROCKWELL SPEAKS: Every Sunday since April 3, 1960 Commander Rockwell has been making speeches on the Mall, at Constitution and Ninth streets in Washington, D.C. Through the summer months the speeches will continue, every Sunday at 2 P.M.
8. HITLER'S BIRTHDAY: On the event of Hitler's Birthday, on April 20, 1960, the American NAZI Party, took steps to counter-demonstrate against the Negro sit-in pickets. Party members dressed in "Ape" costumes were driven around Washington, D.C. in an open convertible carrying

such signs as "We Equals Demands to Eat lunch wid de White Folks". Thousands of people saw this demonstration. Later in the afternoon the ANP picketed the Zoo, and the "Apea" carried such signs as "Free our Brothers" and "We Equals want Civil Rights."

9. DREW PEARSON PICKETED: The American Nazi Party picketed the well known leftist, Drew Pearson on April 26, 1960.

10. NUREMBERG NEW PURIM FOR THE JEWS: The mass trial and murder of National Socialists at Nuremberg should serve as a warning to White Man all over the world, of what may happen to them in the near future. Not only were the German Nazis on trial at Nuremberg but also White Nationalists everywhere--whether they call themselves States Righters, Segregationists, or just plain conservatives. As the German Nationalists mounted the platform and the rope tightened around their necks and snuffed their lives out, so started the destruction of the White Man, wherever he may be. The Nuremberg Circus was just the beginning and it is now continuing all over the world, in the form of International Jewry and its chief tool--the United Nations. The same brainwashed Gentiles who stood and watched while these gallant men died, are now the same ones that are concerned about segregation of the races and States Rights. The same men that called Hitler a "mad-man" are now being dictated to by a Supreme Court who makes its decisions at the will of the American (?) Jewish Committee, and sends troops to carry out these orders. Now what are the true facts on the Nuremberg Trials (Murders).

Behind the scenes the chief prosecutor Gen. Taylor was assisted by the Jews Robt. M. Kempher and Morris Anshau. Julius Streicher was flogged until he was covered with blood, by Jews dressed in U.S. Army uniforms. After this he was forced to kiss the feet of a Negro and Jews spat into his mouth. Many others were tortured until they signed confessions, which were not true. Senator McCarthy said of the trials, "I have heard evidence and read documentary proofs to the effect that the accused persons were beaten up, maltreated and physically tortured by methods which could only be conceived in SICK BRAINS." (Statement to the press May 20th 1949).

Out of the 3,000 people employed at Nuremberg 2,500 were Jews. German soldiers were sentenced to death for obeying orders while the British Military Code demanded unconditional loyalty from the British soldiers. Also while the trials were going on the Jews were making huge profits on the black market as told by Mr. Mark Lautern who was there. The man that executed the Nazis at Nuremberg was the Jew, John C. Woods Short. When Julius Streicher mounted the gallows he said, "Remember! Your turn will come next! You will be hanged by the Bolsheviks!"

How long will it take the White man to realize that this may be the fate of each Racist in the near future if we do not unite together in the fight. How long will it be before the Jew United Nations will pass laws making it illegal for the white man to be proud of his race and defy race mixing and the Communist-Zionist Jews who promote it? How long will it be before you are arrested for defying the Jews and put before a "Circus" and "Tried" for defending your RACE? How long will it be before you mount the scaffold and feel the rope tighten about you neck, while the Jew "Judges" make the world safe for "Democracy".

I can personally assure you for every member of the Party here doing the fighting, that this help and encouragement is not only appreciated, --it is the difference between life and death.



Issue No. 2 June 1960

1. WHITES PLEASE FROM NEGROES: The Belgian Congo will become an independent Nation on the 30th of June, 1960. A Negro Nationalist Newspaper has announced that it will be legal for Negroes to rape White Women after the 30th of the month. Negroes are now looking over the homes of the White people and telling the Whites, "thy'll be ours after the end of the month." Thousands of the Whites are fleeing from the Congo, and South Africa intends to airlift the Refugees to the Union of South Africa. South Africa will gain more people that are White Supremacists from this move.

2. JEWIS PERSPECTIVE ANOTHER OLD MAN: Dr. Walter Schulzke, a 65 year old German was sentenced to four years hard labor for "war crimes." He is said to have ordered the "murder" of 380 mental patients incapable of work. The Jews are not satisfied with charging Hitler with the murder of 6,000,000 Jews. Fifteen years after the war the Jews are still on their murder binge.

3. FORMER U.S. GENERAL SHUBBED: General Sepp Dietrich, the 68 year old former Commander of Adolf Hitler's bodyguard was snubbed recently by 1500 U.S. Veterans when they held a reunion in Wiesbaden, Germany on June 5th. The gave the reason as, "we do not like political Generals."

4. JEWIS STOP NAZI CONGRESS: A neo-Fascist and Nazi Congress was recently supposed to be held in Wiesbaden, Germany. The Jews complained so much that the Police raided the Headquarters of the Movement sponsoring the affair and confiscated the records. Representatives from 800 different groups were supposed to attend the Congress.

5. PEARSON EXPOSES ADENAUER & BEN GURION TEACH-ER: Drew Pearson, well known leftist and Jew lover may finally be waking up on certain matters. Recently he has exposed some trickery between Ben Gurion and Conrad Adenauer. In his column of May 23, 1960, Pearson reports, "Ben Gurion who has a sense of humor, later remarked to a friend--"The difference between Adenauer and Hitler is that Hitler knew the Jews would inherit the earth so he killed six million of them. Adenauer knows that the Jews will inherit the earth, so he wants to join us."

6. SELL HITLER, SAYS THE JEW: Daniel Schweitzer, Jew, permanent Chilean representative to the United Nations was held up in his home recently and the bandits forced him to say "Hell, Hitler."

7. NAZI FREED OF CHARGES---CALLED SENSATION: A court in Graz, Austria in April, freed Oscar Ritter former Commander of the Volkstrum Auxiliary troops in Austria of charges of killing eleven Jews. He said he killed them because they had typhus. This is one Nazi the Jews will not send to jail on false charges.

8. NO JEW GOES WANTED IN PAKISTAN: The Jews have had the International Interpol Police conference changed from Lahore Pakistan to Paris France, because the Pakistanis would not allow Jew police from Israel to attend in Pakistan. Another country has had the courage to defy the Jew Bandits.

9. MURDERER OF KLANSMAN FREED: Several months ago a Klan leader was murdered in Montgomery Alabama while standing up for the White Race. His murderer is a restaurant owner who prefers to hire Negroes instead of Whites.

10. WERNER VON BRAUN: Famous Missile Scientist Werner Von Braun has been subjected to degrading by having to work under a vile looking Jew by the name of Silverstein. Von Braun, who once worked for Hitler has been placed under the direction of Abe Silverstein, Director of Space Right's Development for the U.S.

11. KARL MARX: The grave of the Jew, Karl Marx, the founder of the Jew conspiracy called Communism, was painted with a Swastika on June 5th, 1960. Marx's grave is in High Gate cemetery in London.

12. "SENSATIONAL EXPOSE BY THE COMMUNISTS": Fifteen years after #11, the Communists have finally decided to release a picture of Adolf Hitler as supposed to be photographed after he committed suicide in Berlin in 1945. Earlier reports from the Jew dominated Communist Russia said that Hitler's body had never been found. Could this sensational expose be a wax dummy? Just as the picture of Adolf Eichmann (in an SS uniform) as released from Israel? It seems that both Israel and Russia are in the wax dummy business, these days.

13. BEN GURION ATTACKS MERRILL: Ben Gurion recently made a verbal attack on Indian Prime Minister Nehru, for not establishing diplomatic relations with Israel. Maybe, Nehru values the friendship of the Arabs more than the friendship of dewboy Ben and his gang.

14. DEWBY BEN PROVE OF FORMER NAZI: Dr. Walter Zippert, head of the criminal police of Lower Saxony is being probed for an article he wrote during the war asking for the extermination of Jews in the Polish city of Lodz.

15. NAZIS RISE EVEN UNDER COMMUNIST RULE: Even the Communist Secret Police cannot stop honest White Men from standing up for their race and Nation--even in the face of death. It was reported that the Communists uncovered a group of 41 youths in East Berlin that were running a Nazi Party.

AMERICAN NAZI PARTY NEWS: With the coming of the summer months the American Nazi Party has stepped up its activities. Footnote (Photograph: James K. Warner) of people are getting up the courage to come around and many people are joining. Below is a summary of our activities in the months of May and June, 1960.



1. COMMANDER ROCKWELL SPEAKS: All Patriots visiting the Washington, D.C. area should attend the speech given by Commander Rockwell, or the Well at 2 PM every Sunday. Ever since April 3rd Commander Rockwell has been speaking on the Mall at 9th and Constitution Aves, in D.C.

2. WEINSCHEWER ORDERS INVESTIGATION: On June 7th president Eisenhower had a half hour visit with the leader of the Jew War Veterans. The Jews are starting to feel the sharp edge of truth digging into them, and they know if the truth is allowed to prevail it will mean that a great majority of the Jews in the U.S. will eventually stand trial for treason. After the Jews gave the "words of Wisdom", Ike dictated a memorandum to Attorney General Rogers directing Rogers to look into the matter.

3. NIXON--THE LESSER OF TWO EVILS: The American Nazi Party has given moral support to Nixon in the race for the presidency. Nixon, although a life member of the FAACY is basically a good American and in the past exposed many Communists. On the other hand, Kennedy has written books for the ADL, and if elected as a Member of a minority group, he will open the way for a Jew for president in the elections in 1964. As you may have noticed in the last few months the Jew controlled Magazines, Newspapers, and other means of communication have been giving Kennedy their full support. Nixon has repudiated the support the American Nazi Party has offered him in this campaign.

4. AMERICAN NAZI PARTY BREAKS UP SIX INNS: On June 9th the Jew race mixing circus called "sit-ins" invaded Arlington County, Virginia. As the Negro integrationists and their white stooges moved in on the Drug Fair Drug stores in Arlington, one of our informants notified us of their plan. As they arrived for the sit-ins, a group from the ANP also

arrived with picket signs. After the Negroes had started sitting at the lunch counters, the ANP members went into action, and picketed back and forth in back of the lunch counter-~~right~~ behind the sit-ins. The signs carried had pictures drawn on them and said, "The head of the NAACP is a Jew and is we is or is we ain't equal." After two hours picketing the ANP members went back to the headquarters to get more men. Later that night, Commander Rockwell led a group of seven ANP members back to get it. The crowd of White people by that time had grown to over a hundred, and many of the White youths were arriving at the Negroes. While women were sitting with Negroes at the lunch counters. Police had to protect the sit-ins as they left. The Drug stores that night, Upper Virginia State Law the sit-ins would be expected if the manager of the store ordered the Negroes out. The head of the Drug Store chain, a Jew by the name of Eisenberg would not order them out, although he had all the seats but the sit-ins taken off.

The next morning the ANP returned with still more men and all members wearing Swastika Armbands. This time the ANP passed out pamphlets titled, "NATIONAL Program of the giant, super sectional Jew-Communist, Race-Mixing TRAITOR NEGROES" which while exposing the master plan Jews behind the sit-ins also ridiculed the sit-ins. Jew Drug Store owner, then ordered that the Negroes could stay and sit in but the ANP members would be arrested if they continued to harass the sit-ins. The Arlington Police Dept. cleared out the Drug Store of the hundreds of people that were harassing the sit-ins, but let the sit-ins stay. For several months the Jew press had maintained a "silent treatment" on the ANP, but in this case it was no longer possible. The ANP was getting almost so much publicity for picketing the sit-ins as the sit-ins themselves were getting, and because of this the Jews called of the Arlington sit-ins.

5. NAZI BROTHERS FILED: On 16, Duke Troopers, Dan Hurree and Martin Clayton had to pay fines in the D.C. court for disorderly conduct. While attending the court the previous Sunday they had used the word "damn" in telling a drunken pro-Jew legislator to shut up so they could hear the speech.

6. AMERICAN NAZI PARTY PICKETS FOR EICHMANN: On June 11, 1960 the American Nazi Party picketed the White House in behalf of Adolph Eichmann, who has been illegally kidnaped by Secret Agents from Israel. The picketing lasted about two hours.

JULY 4th!!!

On July 4th 1960 Commander Lincoln Rockwell will speak in Union Square, in New York City. The American Nazi Party plans to get as many members as possible to turn out for the rally. John Squires for many years has been infested with Communist gum, who have been using it to preach their filthy race mixing line they receive from Moscow. In all the time the Communists have been using Union Square to spread their filth, Jew if any Jews have ever complained about their meetings. Now that Commander Rockwell has asked for a permit to speak (use Union Square) all the Communist, Jewish, and Negro Integrationist groups have gone into an uproar and done everything that they could to get the city officials to deny the American Nazi Party the permit for the 4th. The Jews and Communists have been flooding the Mayor's office with Mail and Telegrams urging him to stop the Commander from speaking. We urge all patriots to turn out for the July 4th rally and help break the Jew Communist curfew in America.

WHAT'S HAPPENING IN SOUTH AFRICA? How can South Africa hope to maintain its racial standards when rats are chewing at its very foundation? Jews were recently exposed as being the chief brains behind the Integration push in South Africa and many were arrested. Now we find that 16 of the top officials in Johannesburg are Jews and also the Mayor--Alan Goshel. 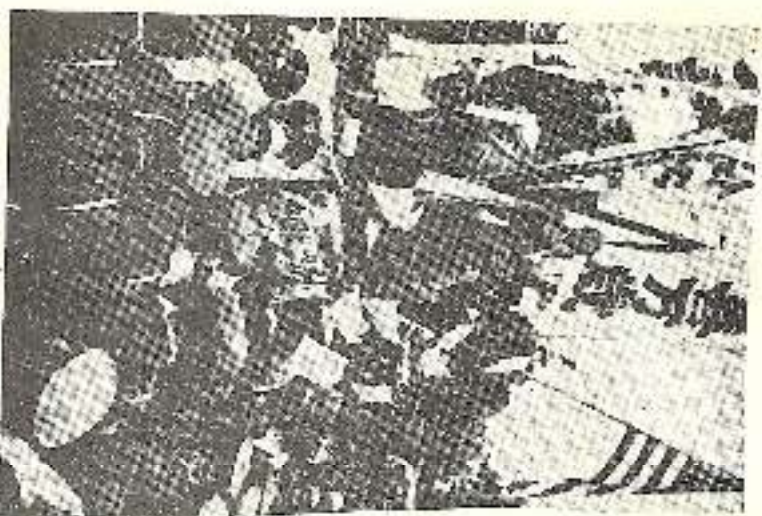

1. JEW LEADS ANTI-FASCIST RIOTS: The Jew, Carlo Levi, who during the war was one of the leaders of the pro-Communist partisans, was instrumental in setting off riots against the Italian Fascists when they recently tried to hold a Congress in Genoa, Italy.

2. NO JEWS WANTED: Leonel Brizola, the Governor of Rio Grande do Sul, Brazil, has recently ordered that anyone found investigating German immigrants charged with war crimes "would be arrested".

3. GERMANS HIT FOR DEFEATISM: General Cord von Hobe, a general in the West German Army, criticized the German population for not backing up the soldiers near the end of WW II, when enemy soldiers invaded Germany.

4. TURKISH JEWS "SCARED": Recent reports indicate that the Turkish Jews are afraid that Ismet Inonu will be re-elected to power. When Inonu was in power from 1938 to 1950, Jews were deported, taxed heavily, and put into labor battalions. All true Turks pray that Inonu will be elected.

5. UNCONFIRMED REPORT: Certain news-papers reported that 500 Argentine Youth demonstrated against the Jews in Argentina recently. So far we have not received any confirmation of this from our contacts in Argentina.

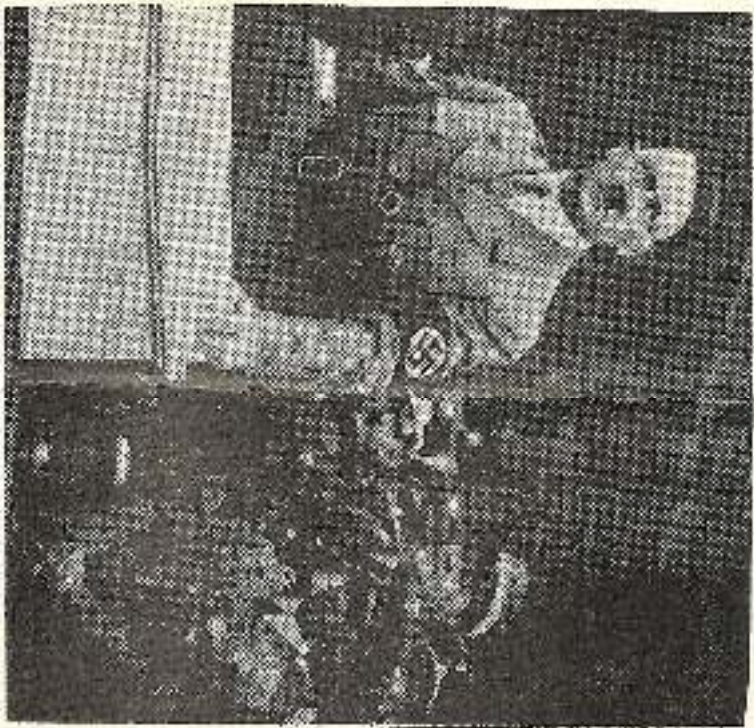
6. CASTRO RUINS JEWS: Cuba's 12,000 Jews are quite worried these days over Fidel Castro's policies of State Ownership. It seems that Castro is confiscating businesses owned by Jews. Evidently, Castro doesn't know that Communism is Jewish, as he has also kicked out the last Jew member in his government (in high position).

7. NAZIS RECENTLY ARRESTED: (a) Erich Depner, former Gestapo chief in the Hague and (b) Wilhelm Koeppe, former SS General,

8. FREEDOM IN WEST GERMANY: In 1958, Ludwig Zind was sentenced to 1 year imprisonment for stating: "Not enough Jews had been gassed." After being sentenced, Zind fled to Egypt and later returned to Europe. He has reported that he has been trailed all this time by Israeli Secret Police and by the West German police who work indirectly under the Jews.

9. KLAN LEADER DIES: Edwin Edwards, head of the U.S. Klans, died last month at the age of 51.

10. KESSELRING DIES: Field Marshall Albert Kesselring died at the age of 74. Kesselring was the head of the German forces in Italy during WW II. After the war he tried to reform the German veterans' group "Stalhelm", or Steel Helmets, and at present it is building up membership.



SOCIAL JUSTICE CORRESPONDENT, Veritas, speaking of Hitler, in the December 7, 1936 issue of Social Justice said: "Hitler today is one of the leading personalities of the world, his private life is to be admired, a real puritan. He has made of Germany defeated, a new, united, great nation. He has brought back to his Fatherland the pride of industrial achievements, and scientific improvements..."

But what I admire in Hitler is his stand **AGAINST Communism!** Social Justice, Father Coughlin's powerful organ of public opinion certainly will agree that Hitler is today the European Champion, the bitterest foe of Communism; which is the destroyer of peace and civilization."

EDITORS NOTE: Rev. Coughlin fought hard against Communism, as did Hitler. Both men were let down by their own people. The Jews succeeded in silencing them both, but a new resurgence is at hand, and the Jews will pay dearly for their treason to mankind.

RIOT ON JULY 3rd: On July 3rd eleven members of the ANP went to the Mall at 9th and Constitution Streets in D. C. with Commander Rockwell to speak. Over 250 Jews arrived in force, and after approximately 45 minutes the Jews, by sheer numbers, forced their way through the ropes and attacked the Commander and ANP members. After 5 minutes of fighting, eleven members of the ANP and six Jews were arrested. During the fight Major J. V. Morgan was dragged through the ropes by six Jews, choked unconscious, had two ribs badly bruised and his leg disjointed. Lt. Warner had his ear almost bitten off by a Jew. The next day the D.C. officials made the ANP change the place of the speech to 5th and E streets in D.C. At the new location, weeks later, Jews came and created another disturbance. When ANP members tried to protect the Commander's right to speak, sixteen of them were arrested, including one man holding the American Flag, for "Disorderly Conduct".

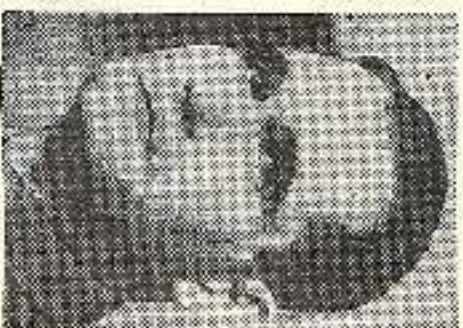

During the time the Commander was in the D. C. General Hospital Mr. Warren H. Folks, of "Save America, Inc.", was working day and night to get the Commander out. As a result - Mr. Folks has been receiving anonymous threats from Jews, and his business has been boycotted by the Jews.

NAZI PARTY NEWS

COMMANDER ROCKWELL: On August 4th, Commander Lincoln Rockwell was released from the Washington D. C. General Hospital after being officially adjudged SANE and competent to stand trial and to aid in the preparation of his own defense. The Commander was ordered to the hospital on July 27th by Judge Neilson, who had heard five hours of testimony (90% of which was in favor of the Commander). A total of four psychiatrists, three Gentiles and one Jew, ALL, said the Commander was SANE.

PICKETING SAMMY DAVIS, JR. On July 12th, Sammy Davis, Jr. got the surprise of his life when 16 members of the American Nazi Party picketed him at the Lotus Restaurant in Washington. When the British Fascists in London picketed him a few months ago, he said: "It could never happen in the U.S.". Later that week the ANP found out that Sammy was to appear on a Jew radio show in one of the D.C. restaurants. ANP members showed up in force, and Sammy cancelled his appearance.

U. S. MARINE RECEIVES FRAUDULENT

DISCHARGE, Quantico, Virginia, 6 July 1960:

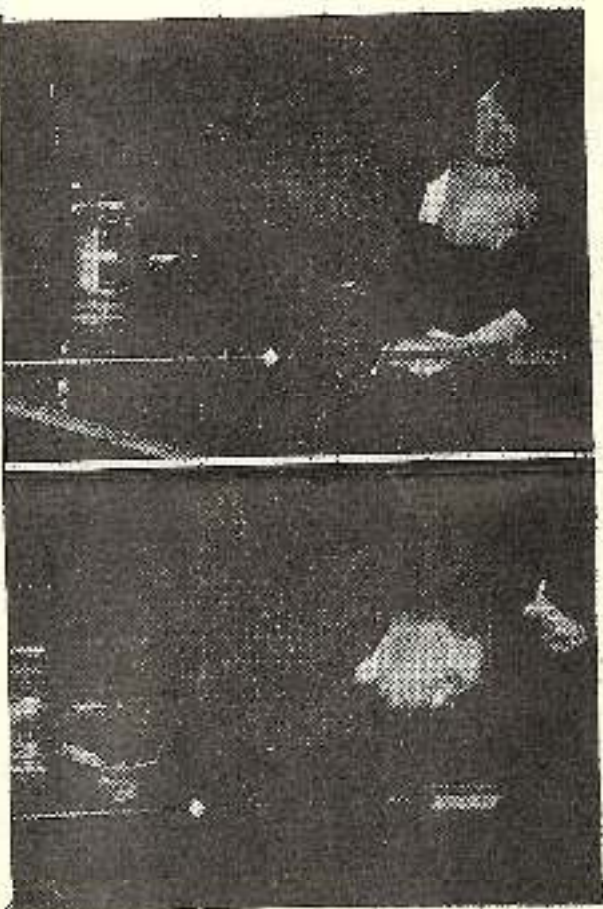
Marine Pfc John Patler received a General discharge today for "unsuitability" on account of his participation in anti-Communist organizations. Pfc Patler was shown an Honorable discharge with his name typed thereon and was asked by his Commanding Officer to sign for it. In one hour and ten minutes, this unbelievably short amount of time it took to process Pfc Patler, he returned to pick up his Honorable discharge --- and found that he was tricked into signing for a General discharge, and that the Honorable was used as bait to procure his signature. The papers had been re-inserted into the typewriter and the words "under" and "conditions" had been typed in, before and after the word "honorable".

PICKETING IN MARYLAND: In July, the ANP members picketed Glen Echo Amusement Park asking the owners to keep it segregated. Negroes are picketing the park trying to end the segregation policy of the park. The Negroes also picketed a theater in Bethesda, Maryland, and the same day they started - the ANP was there to counter picket them. The manager of the theater, Mr. Hiser, said that he will not change his policy.

ON THE CONGO: In the last issue of the NSH we predicted that the White Women in the Congo would be raped. When the Congo became an independent state, the Negroes went wild and raped white women, including nuns. However, this was played down in the press, - but let one Negro be harmed in South Africa and the press harps on it for months.

ANOTHER ADL FRAMMUP: On the 26th of July, Dan Burros and John Falter went to the ADL offices in D. C. in order to pick up some free literature. After they left the building the Jews put up Swastika stickers inside the elevator and blamed it on the boys. As anyone knows, within the last year the ANP has given away thousands of these stickers, and evidently some came into the hands of the Jews. The boys were locked up in the D. C. jail and the Jews made them post \$500 bonds, which is absurd for so-called "abuse to property." They were immediately suspended from the Party until after the trial on the 30th of August.

PICKETING THE WHITE HOUSE: WORLD Commander Rockwell was in the D. C. General Hospital, members of the ANP picketed the White House for several days in a row, protesting his detention.

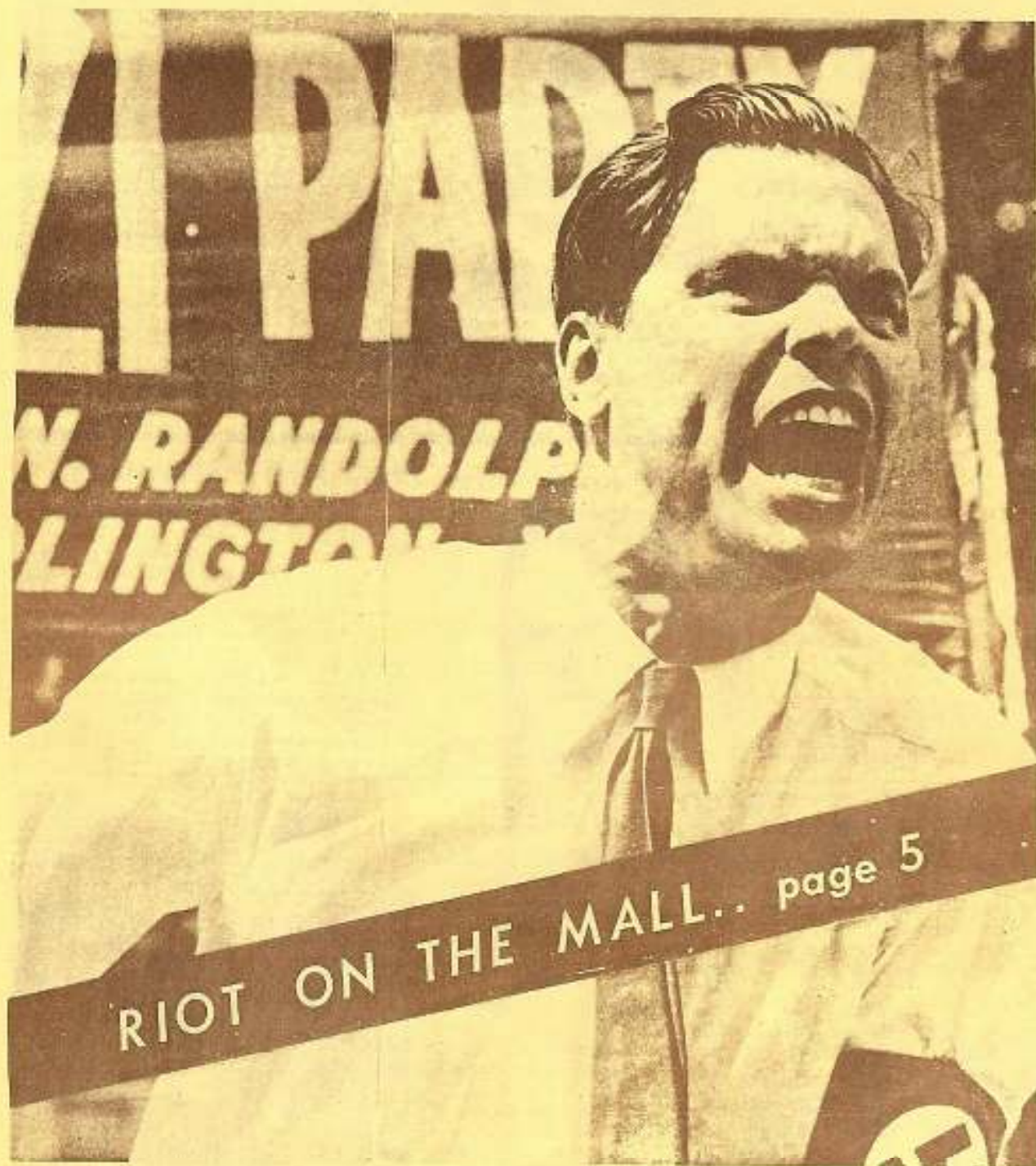

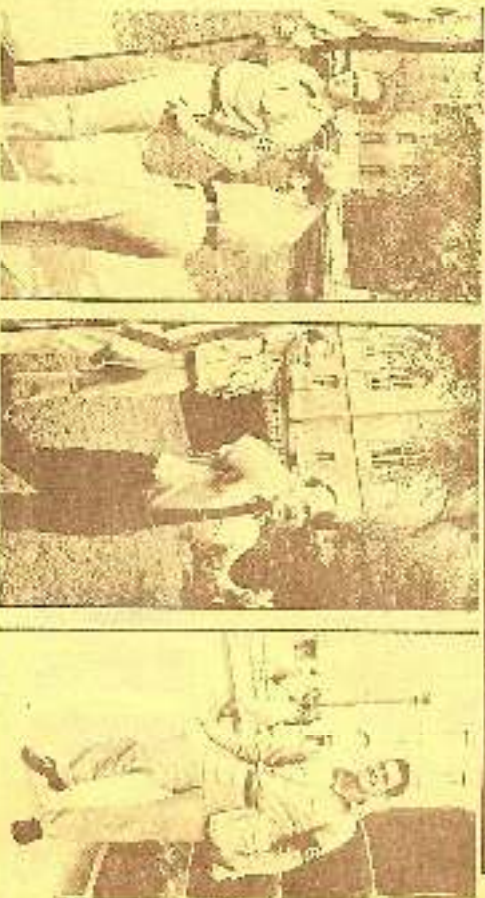

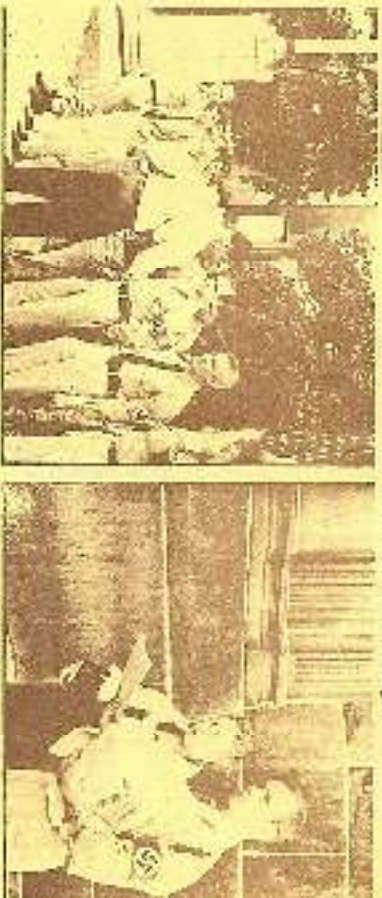

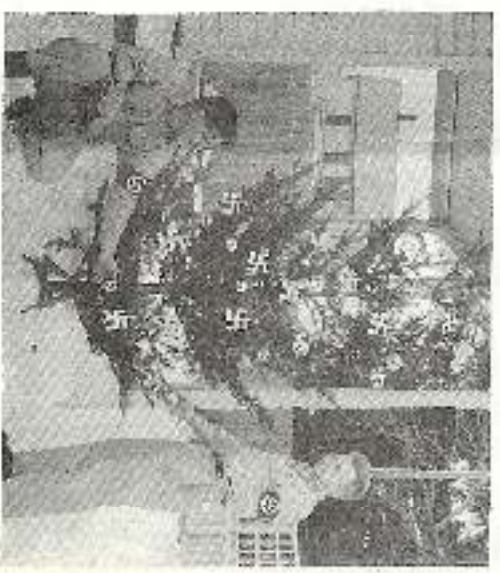

PARTY OFFICERS FILE COMPLAINT

On December 30, 1960, five party leaders filed with the Federal Court against Interior Department officials, Director of Civil Liberties, and three officials of the Anti-Defamation League. COURT VICTORY in Kennedy picket case

On December 15, 1950, Chief Judge John L. Smith Jr., of Municipal Court held that Commander Bookman and four of his Storm Troopers were not guilty of disorderly conduct when they picketed Kennedy headquarters in Washington. 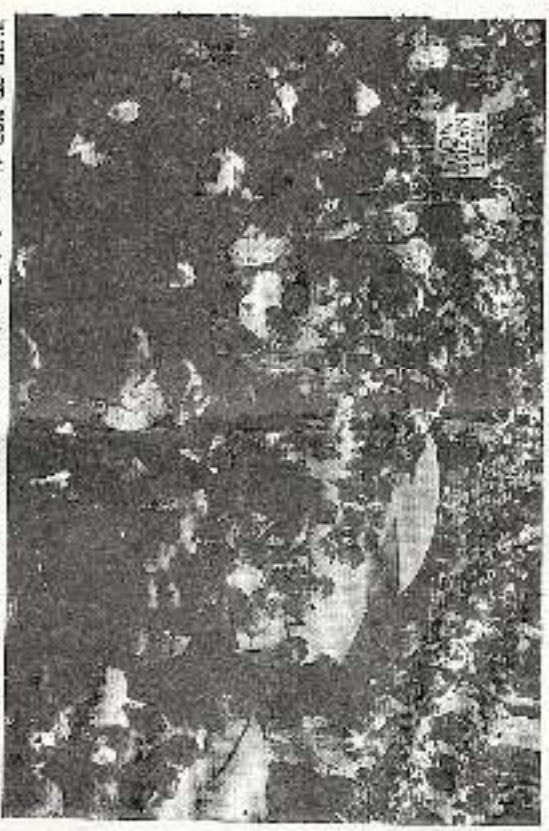

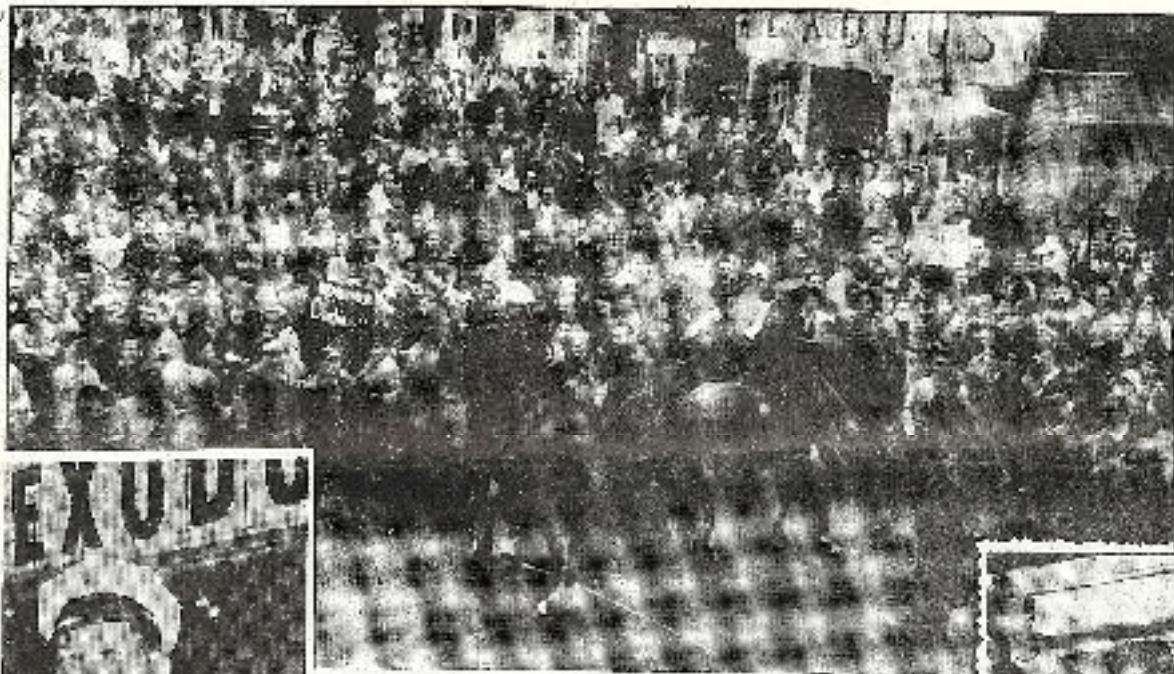

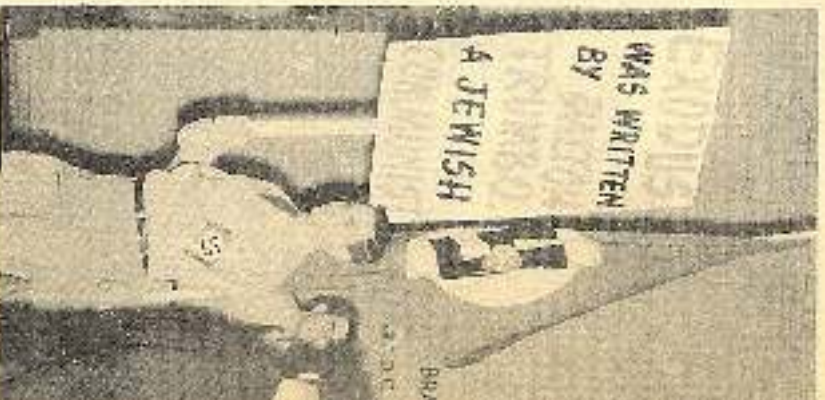

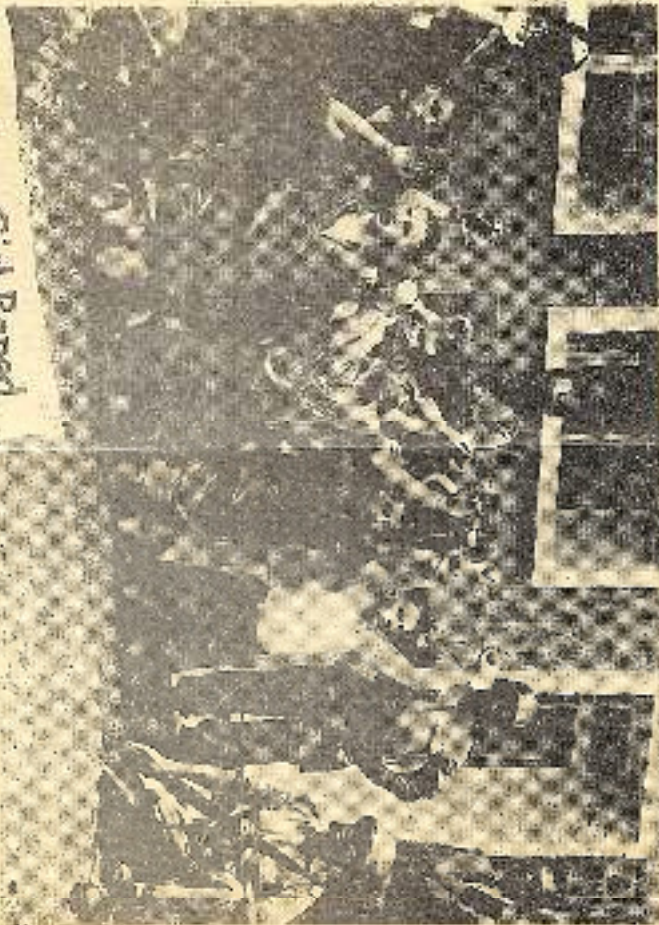

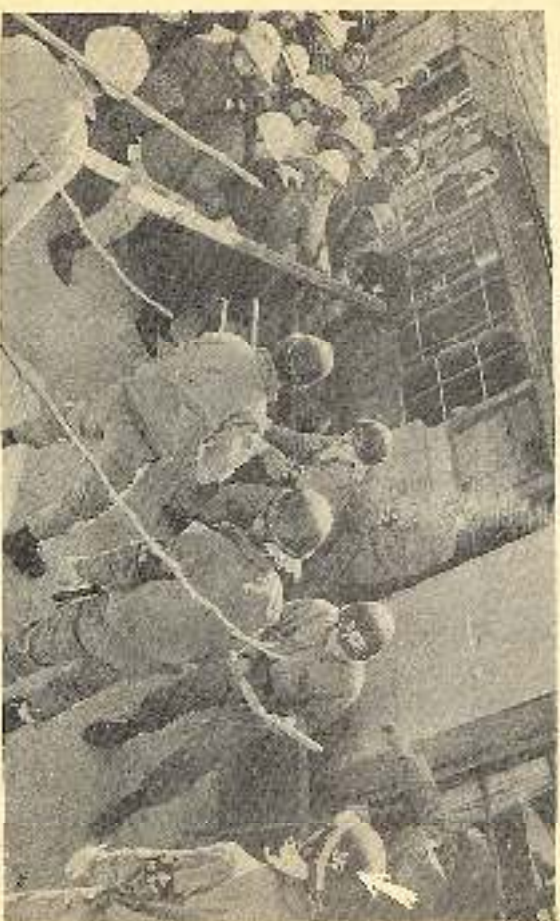

Prosecuting attorneys for the case consisted firstly of D.A.'s Doolery and McNeil — both recipients of numerous Communist front citations, among them a citation for membership in the notorious National Lawyers Guild, listed as substitute by the U.S. Attorney General. Opening the case for the prosecution was Joseph Assistant D.A. Burton Klein, who conveniently became emotionally 'upset' while questioning the Commander — a task that proved far too much for Mr. Klein to handle.

Witnesses for the case were an army of frightened policemen whose livelihood stood in the balance; the chairman of the New Orleans chapter of the Anti-Defamation League, Moses Shweg, a well-regarded Jew who kept running back and forth from his seat to the District Attorney with 'advice'; and two other A.D.I. snoots, Sammie Katz and Louis Bernart — both of whom admitted to standing a special A.D.I. meeting at which seats to deal with Roosevelt were thoroughly discussed.

In two full days of testimony the devious, shrewd, through confident witnesses, led the Commander and his troops scolded with all police orders and regulations. The crowd which the Nazi parties were supposed to have 'unreasonably assumed' consisted of not more than twenty or thirty persons, mostly sympathizers, who were standing across the street under arms to keep out of a very heavy flow of traffic. In spite of all the facts establishing the innocence of the Storm Troops, Judge Higgins found all of the Nazis guilty, imposing sentences extending to each man's entire life if there received the bulk of the punishment.

The case is presently being appealed, and it is certain it will be fought all the way up to the U.S. Supreme Court. The case involves the Constitutional question of whether or not the American Nazi Party has the right to pick people up and thereby express its views opposing Communism and the Jewish Commander influence behind non-racism.

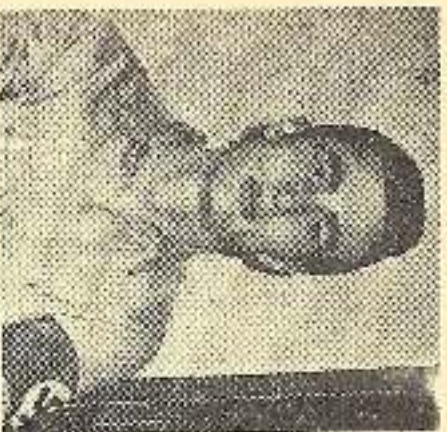
U.S. Storm Troopers Oppose Pacifists

High Court Backs Nazi Speech

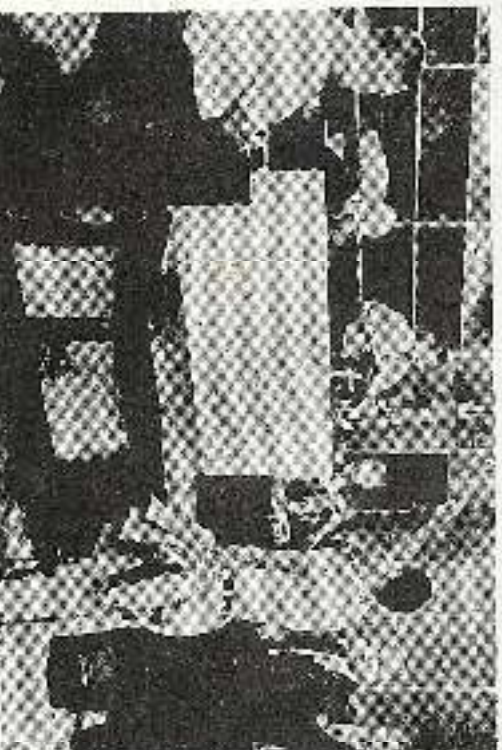

worried about an Internal Revenue major attack — not because we were doing anything wrong, but because we simply didn't know how to set up our affairs in a manner to defend ourselves from the inevitable assault. And when the Jewish Mr. Caplin was appointed head of Internal Revenue, we began to look to our passports and false whiskers.

Then, almost eerily, Karl Allen was here. He was so quiet and unobtrusive he was hardly noticed as he came into headquarters. But we desperately hoped he would contact us so we could caution him that he was violating postal regulations. He never revealed himself, however, and when the Jews got the postoffice after him, we were forced, in line with our utter necessity of remaining scrupulously legal, to help them all we could — which we did. In late August they picked him up — completely clearing us, but also saddening us. He will get UNNECESSARY prison time. But perhaps it will be a good lesson to others who might think of painting swastikas, sending threats, etc. DON'T DO IT! We can win and ARE WINNING legally. When somebody does something illegal, they play directly into the hands of the Jews, and jeopardize the Party and the men who have risked their liberty and lives for so long.
